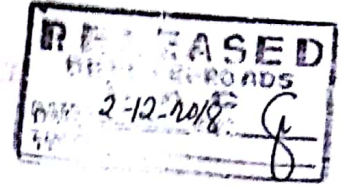

INVITATION TO BID FOR SUPPLY & DELIVERY OF LOGISTICS AND MATERIALS SUPPORT FOR THE OFFICIAL USE OF DENR AGUSAN DEL SUR

1. The DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, PENRO AGUSAN DEL SUR, through the GAA-Fund-101 intends to apply the sum of **TWO MILLION THREE HUNDRED FORTY THOUSAND (Php2,340,000.00) PESOS ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply & Delivery of Logistics and Material Support for the Official Use of DENR Agusan del Sur with Contract No. 2018-02-001*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DENR-PENRO Agusan del Sur now invites bidder for the *Supply & Delivery of Logistics and Materials Support*. Delivery of the Goods is required *within fifteen (15) days from the receipt of Notice to Proceed*. Bidders should have completed, within *the last two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from DENR-PENRO ADS and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM. Monday to Friday, at Procurement Section Office, PENRO Office, Government Center, Patin-ay, Prosperidad, Agusan del Sur.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *February 14, 2018 until 10:00 am of March 5, 2018* from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Note: For lot procurement, the maximum fee for the Bidding Documents for each lot shall be based on its ABC, in accordance with the Guidelines issued by the GPPB; provided that the total fees for the Bidding Documents of all lots shall not exceed the maximum fee prescribed in the Guidelines for the sum of the ABC of all lots.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The PENRO Bids and Awards Committee will hold a Pre-Bid Conference¹ on *February 19, 2018, 10:00am* at **PENR Conference Room, Government Center, Patin-ay, Prosperidad, Agusan del Sur**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before *March 5, 2018, 10:00am*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on *March 5, 2018, 10:30am* at PENR Conference Room, Government Center, Patin-ay, Prosperidad, Agusan del Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Each bidder shall submit one (1) original copy, and two (2) additional copies of the first and second components of its bid.

8. The PENRO Bids and Awards Committee reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
